EXPLORE

We always explore options to improve service.

INFORM

We inform you of the decision made by the directors.

MEMBER VOTE

If the directors vote 'yes,' the members have the final vote on whether to combine the co-ops.

- You will need to turn off your 'pop-up blocker' while you vote.
- You can't vote through the Smart-Hub app.
- Vote on-line until June 7th 5:00 p.m.

-VOTE BY MAIL

Tips:

- Send your ballot in so it gets delivered to the Minnesota address by June 7th.

-VOTE AT THE MEETING

- If you don't vote before the Annual Meeting, join us and take the opportunity to vote at the event.
