

**Instructions for completing the
Assignment of Capital Credit Account of Deceased Natural Person and
Agent's Appointment Card:**

The Agent's Appointment Card gives Jasper County REMC authorization to issue Capital Credit checks to the person named as Agent on this form. It then becomes the Agent's responsibility to distribute these monies to the heirs.

Please follow these guidelines when completing the card:

- Print deceased REMC member's name on top line of card. Please enter name as recorded on Jasper County REMC records. We will provide you with the account number.
- Fill in member's date of death on first line of first paragraph.
- Fill in Agent's name on first line of third paragraph. All persons signing card should agree on one person to be named as Agent.
- All DIRECT heirs (husband, wife, sons and daughters) MUST sign the form. EACH signature must be notarized.
- If you are not a DIRECT heir, you must submit a copy of a legal document, along with the notarized card, stating you are an heir to the member's estate. If there are many heirs listed on the provided legal document, those heirs MUST ALL sign the Agent's Appointment Card and have the signatures notarized.
- For convenience, when several signatures are required, more than one card may be used as long as each card shows the same Agent. The Agent should coordinate the cards so ALL cards are returned at the same time to REMC in ONE envelope.
- Jasper County REMC will provide free Agent's Appointment Card Notary services for an heir signing the Card in our office.
- Please review the card(s) for accuracy and completeness before returning to Jasper County REMC.

Assignment of Capital Credit Account of Deceased Natural Person and Agent's Appointment Form

The undersigned, being first duly sworn on oath, depose and say:

1. That _____ died on the _____ day of _____ year _____, was a member of Jasper County Rural Electric Membership Corporation, and as such member had credited to him certain patronage capital.

The undersigned are each over the age of 18 years and represent that they are all either heirs at law of said decedent or the beneficiaries of the Last Will and Testament of said decedent, duly admitted to probate and to their knowledge there are no other individuals that can make a valid claim against the estate of the decedent. That all debt, claims, taxes and liabilities of said decedent and his estate, if any, have been paid, and that the undersigned are the sole and only persons entitled to payments and distributions from said patronage capital and that any estate in the name of the member is closed.

The undersigned do hereby constitute and appoint _____, as the Agent to receive and receipt for payments and distributions of and from said patronage capital hereafter made, and do hereby authorize and direct Jasper County Rural Electric Membership Corporation to make all such payments and distributions of and from said patronage capital to said Agent. The appointed Agent hereby assumes all responsibility for distributing the patronage capital, pursuant to the decedent's Last Will and Testament and any and all applicable laws, rules, and regulations, paid to Agent by Jasper county Rural Electric Membership Corporation.
4. The affidavit is made for the purpose of inducing Jasper County Rural Electric Membership Corporation to make said payments and distributions to said agent, for and on behalf of the undersigned, and the undersigned further agree to indemnify and save Jasper County Rural Electric Membership Corporation harmless from any and all claims, demands, actions or loss of any kind arising out of such payments and distributions. In consideration of the release of patronage capital to Agent, each undersigned hereby forever releases any and all claims and rights which he or she had, has, or may hereafter have against Jasper County Rural Electric Membership Corporation arising out of or associated with the payment of any patronage capital due to the above-named decedent in the past, present, or future.
